This document provides information to you regarding the direct debiting of your account. By signing the Direct Debit Request (DDR) below you acknowledge you have read and understood these terms. Direct Debiting is not available on the full range of accounts. If in doubt please refer to your Financial Institution. <b>How the DDR will be used 1.</b> The DDR will be used to debit amounts due by you under your loan agreement with the lender. <b>2.</b> Where a payment due date falls on a non-business day, the amount will be debited on the next business day. <b>3.</b> The purpose for which the DDR is used will not be changed without giving you at least 14 days notice. <b>4.</b> All information relating to your nominated account will be kept private. <b>Your rights 5.</b> You may stop any individual debit by giving written notice to the mortgage manager. This notice must be received by the mortgage manager at least 5 business days prior to the payment due date. <b>6.</b> You may request deferment or alteration to payments under the DDR by contacting the mortgage manager. There is no obligation to agree to any request. Any request must be given at least 5 business days prior to the payment due date. <b>7.</b> If you consider that a debit has been incorrectly made, you should contact the mortgage manager determines that the debit was correct, you will be told why. <b>Your commitment to us 8.</b> You may not terminate the DDR without the mortgage managers consent. <b>9.</b> You must ensure there are sufficient funds available in the nominated account to meet each debit on its due date. You must ensure that the account you propose to debit allows direct debits. You should check this directly with the financial institution at which you maintain the account. You must not close or alter the account without the mortgage managers prior written consent and unless approved alternate payment arrangements have been made.
